PROFESSIONAL EXPERIENCE

1988-present Instructor, then Assistant, now Associate Professor Colorado State University in the Department of Natural Resource Recreation and Tourism. I am the concentration leader for the Park and Protected Area Management Concentration. Among the the courses I teach or have taught are: Land Use Planning, Wilderness Management, Protected Area Planning, Management of Open Space and Natural Areas, Ecotourism, and Social Science for the Natural Resource Manager, and seminars in related topics. My research focuses on: land use decision structures, private land

conservation, the human dimensions of natural resource and park and protected area management, impacts to parks and protected areas, resource interpretation/education and ecotourism. In addition to teaching, research and advising, I direct CSU's Center for Protected Area Management and Training which provides technical assistance and research and training in both the US and Latin America. (see Research, Teaching, Service sections) I am also the designated professor/advisor in our department for campus interdisciplinary programs in Conservation Biology and Ecological Studies and the Peace Corps Internationalist Masters degree progam.

1984-1986 Extension and Instructional Specialist and one of four senior project staff for: The USAID/CATIE Regional Watershed Management Project for Central America.

As a member of the interdisciplinary team I helped to establish this project which operated out of the Tropical Agricultural Center for Research and Teaching (CATIE) in Turrialba, Costa Rica. We provided short courses and technical assistance to governmental and non-governmental agencies in Panama, Costa Rica, Honduras, and Guatemala in watershed management, soil conservation, land use planning, water quality, extension and other topics. We also established the region's first masters degree program in watershed management and laid the groundwork for an experimental watershed in Rio Tuis C.R.

My responsibilities included general project planning, curriculum design, teaching and co-teaching graduate courses in extension, watershed management and helping to design and conduct short courses in soil conservation, watershed management, water quality monitoring integrated resource management and extension. I also developed a variety of outreach materials. Much of our time was spent in the countries conducting short courses, mobile seminars, and working with agency personnel in the field (agronomists, foresters, and park rangers etc.). We also conducted meetings and seminars that were aimed at increasing the awareness of upper level decision makers about the critical nature of watershed management in their countries.

1972-present In addition to the above activities, My wife, sons and I own and operate a farm near Ft. Collins Colorado where we raise alfalfa, corn, pinto beans, barley and cattle. We were honored by the State of Colorado and Division of Wildlife as runners up for Landowners of the Year for 1995 and by Larimer County in 2001 for our wetland restoration and wildlife habitat practices. I use the farm to teach conservation practices, restoration ecology, habitat mitigation, land use planning, monitoring and evaluation.

RESEARCH

My research is more applied than theoretical but utilizes and contributes to theories pertaining to perceptions and motivations of resource users, learning, technology transfer and planning. Problems addressed are generally those facing protected area and other resource managers or environmental interpreters and educators. Typically, both human and biophysical dimensions of a given problem are addressed together.

TEACHING, ADVISING, CURRICULUM DEVELOPMENT

I am the faculty leader for the park & protected areas concentration. We (Drs. Newman, Theobald, Manfredo, Bruyere, Haas and I) are active in the revision of this concentration and the development of a new masters degree in protected area management for returning professionals. We are developing a client agency advisory committee to assist in this process.

Regular courses taught 1990 - present: NR 440 Land Use Planning, RR 439 – Management of Open Space and Natural Areas, NR 352, 460 & 520 Wilderness Management courses, NR -522 Wilderness Ecosystems Planning, NR - 387 and 487 - Natural Resource Internship, RR 330 - Social Science for the Natural Resource Manager, NR 592 - Thoery and Design of Nature Reserves. Guest lectures are given annually in classes in recreation, forestry, watershed management, and international development courses.

Graduate student responsibilities typically include being major advisor for 8 - 12 students and serving as committee member for another 6- 8 students annually. I have been the advisor for several undergraduate senior honors thesis students. I am the head of the Protected Areas Concentration and de-facto undergraduate advisor for students interested in the Peace Corps, and other international opportunities. I also spend considerable time as an advisor to students in the College's interdisciplinary programs in Conservation Biology and Ecological Studies.

I helped to update and refine the department's internship program, developing new administrative strategies and materials, opportunities for interns, a self study learning center for those seeking internships, and a revision of the course content for NR 387, the pre-internship course.

For the past 15 years I have worked with the staff of our Center for Protected Area Management and Training to develop and conduct a great variety of courses, workshops and training programs. Such programs include one six week training programs in watershed management for 20 Ecuadorian resource managers and environmentalists (USAID's Andean Peace Fellowship Program); and 14 one month long courses in the management of wildlands and protected areas for 20 professionals from 6 countries in Latin America. I assisted in the development of a senior level protected area seminar now offered through the Consortium for International Protected Area Management (CSU, UMT, Idaho). Most of these courses and workshops are conducted in Spanish and involve extensive field work. Since virtually all participants need sponsorship, it is necessary to raise approximately \$95,000 for each course. Sponsors typically include, USAID, UNESCO, World Wildlife Fund, The Nature Conservancy, The National Park Service, USDA Forest Service, The Bureau of Land Management (who also send instructors) and foundations. Most participants are unit administrators in their countries.

SERVICE AND TECHNICAL ASSISTANCE

As Director for the Center for Protected Area Management and Training (CPMAT) and I provide or coordinate training and technical assistance in the areas of wildland and protected area management for the federal land management agencies, state resource management agencies, and both governmental and non-governmental international development and conservation entities such as UNESCO, IUCN, USAID, USDA Forest Service International Programs, Conservation International, The Nature Conservancy, World Wildlife Fund and others.

I am a US delegate to IUCN's World Commission on Protected Areas (WCPA) and an advisor to the 2003 World Parks Congress – streams on Capacity Building and Governance. I am an advisor to UNESCO's World Heritage Program regarding training for World Heritage Sites.

I am an Executive Committee and Steering Committee Member for the Consortium for International Protected Area Management (CIPAM), which includes CSU, U Montanta, U Idaho, and Forest Service International Programs office.

Locally, I have served on a variety of Larimer County, and Ft. Collins boards and commissions related to natural resources. I am currently in my ninth year as a member of the Larimer County Planning Commission and sixth year on the Larimer County Agricultural Advisory Board.

Additionally, I serve as a reviewer for four academic journals and serve on the editorial board of one – the Journal of Ecotourism.
